विषय/Subject: Timeline fixation for peer appraisal data upload and Scope Certificate generation under PGS India webportal-reg

As per the Clause 6.1.1.c of PGS India guidelines peer inspection should be completed by Local Group (LG) 15 days before harvest of crops. In this relation PGS India Secretariat has observed that while uploading the peer inspection data by LG and at the time of issuance of Scope certificate by Regional Council (RC) the time limits mentioned in the clause are not being strictly adhered to.

It has also been noticed that many State Govt. and RCs are requesting for extension of time line behind limits and it becomes very difficult for PGS India Secretariat to deal with making changes in webportal time and again. Ultimately this leads to indirectly affect in PGS India system integrity.

Therefore, keeping in view the above in mind PGS India Secretariat suggests to follow seasonwise timeline for peer inspection data upload by LGs/Individual farmers (IFs)/ Large Area certification (LACs) and issuance of Scope certificate by concerned RCs as given below:

Time line fixation for completion of peer inspection activity and issue of scope certificate of each season for every year:			
Season	LGs time period to upload data	RC time period to issue scope certificate	Total Duration for season to compete peer inspection and certification
Rainy/ Kharif	June to November of every year (6 months to upload data from LG)	December to January of every year (2 months grace period to issue scope certificate only)	June to January of every year (8 months) complete entire season work
Winter/ Rabi	October to March of every year (6 months to upload data from LG)	April to May of every year (2 months grace period to issue scope certificate only)	October to May of every year (8 months) complete entire season work
Summer /Garmi	April to September of every year (6 months to upload data from LG)	October to November of every year (2 months grace period to issue scope certificate only)	April to November of every year (8 months) complete entire season work

The timeline is updated in PGS India webportal therefore, all RCs and Service providers (SPs) are hereby directed to strictly follow the timeline as given above, failure of which lead to non compliance against RCs/SPs/LGs/IFs/LACs.
